

# **Lee W. Hughes Legacy - Juried Art Show**

## **ELIGIBLE ARTISTS**

All artists who studied with Lee W. Hughes during the 40 years that he taught in New Jersey are eligible. This show will be a celebration of the legacy he created with every artist he taught. Each artist should submit their BEST work. It does not have to be a painting they did with him or even one that he has seen. It does not have to be for sale. If the artist does not own it, they must bring written permission from the owner that they can transport and display it.

## **ORIGINAL PAINTINGS ELIGIBLE**

Watercolor, oil or acrylic paintings on canvas, paper, linen or board will be accepted.

All must be framed and wired for hanging.

## **ONE WORK WILL BE ACCEPTED PER ARTIST**

Paintings with a maximum size of 40" and a minimum size of 16" in any direction will be accepted. Only works not previously exhibited at the Library will be accepted. Paintings must be dry, properly framed, and wired for hanging. The curator reserves the right not to hang any submission that is framed insecurely or does not meet the size requirements. All artists will be contacted by email or telephone on the evening of June 21.

## **PAINTINGS MUST BE LABELED WITH THE ENCLOSED FORM WHICH SHOULD BE COMPLETED IN ADVANCE OF DELIVERY.**

## **RECEIVING ARTWORK**

One (1) submission per artist is to be brought to the Library by the Artist on Thursday, June 21, 2007 between 10 AM and 12 Noon. Please complete a label and attach it to the back of the painting before bringing it to the Library. The label is in this packet. ## **ALL ENTRIES WILL BE JURIED**

Paintings not selected for the show are to be picked up at the Library between 11AM and 12 Noon, on Friday, June 22, 2007. Anyone picking up or delivering art work, other than the owner, will be required to present a signed authorization and the receipt.

## **RECEPTION**

There will be a reception, open to the public, Sunday, June 24, 2007 from 2 to 4 PM.

## **REMOVAL OF ART AT END OF SHOW**

For purchasers and artists: Monday, July 30, 2007 from 10AM to 12 Noon.  
Artists: please bring your receipt with you.

## **EXHIBIT DATES AND HOURS**

The show will run from June 21 through July 30, 2007. All paintings must remain in the show until it closes on July 30<sup>th</sup> at 10AM. The show will be on view during regular Library hours when the Community room is not in use.

## **SALES**

Artwork entered in this show **MAY** be for sale. All checks will be made payable to the artist. It is customary for exhibitors to donate to the Bernardsville Public Library at least ten percent (10%) of the proceeds resulting from sales at the exhibit. Sold artwork must remain in the show until it is over.

## **LIABILITY**

Entries will be handled with all possible care. However, the curator and Library Staff and its volunteers will **NOT** be responsible for any loss or damage that may occur.
