What to Do If You Received the J&J Vaccine

If you received the Johnson & Johnson (Janssen) COVID-19 vaccine, your risk of having a blood clot is very low and that risk will decrease over time. Contact your healthcare provider and seek medical treatment urgently if you develop any of the following symptoms:

- Severe headache
- Backache
- New neurologic symptoms
- Severe abdominal pain
- Shortness of breath
- Leg swelling
- Tiny red spots on the skin (petechiae)
- New or easy bruising

Symptoms may show up within 2 weeks of vaccination. If you have any adverse events after vaccination, report them to [v-safe](#) and [VAERS](#).
